Assignor does hereby assign, convey and transfer unto Assignee, and Assignee's successors, assigns, and legal representatives, Assignor's entire right, title and interest in and to the Assigned Trademarks arising under or pursuant to any and all United States and other countries' laws and any international treaties relating to the protection of trademarks, together with the goodwill of the business symbolized by the Assigned Trademarks, as fully and entirely as the same would have been held by Assignor had this assignment not been made.

Assignor hereby further agrees for itself and its successors, assigns, agents, and legal representatives to execute upon request any other lawful documents and likewise to perform any other lawful acts which may be deemed reasonably necessary to secure fully Assignor's rights in and to the Assigned Trademarks, to Assignee, its successors, assigns, and legal representatives.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office and the relevant officer in any other foreign country, to record this Assignment of the Assigned Trademarks to show that all of Assignor's right, title and interest in and to the Assigned Trademarks reside with Assignee, its successors, assigns, or legal representatives in accordance with the terms of this Assignment.

To the extent any of the provisions set forth in this Assignment conflict with the Purchase Agreement, the parties agree that the provisions set forth in the Purchase Agreement shall prevail.


