WHEREAS, MCGLADREY & PULLEN LLP, an Iowa limited liability partnership (the "Borrower") , and RSM McGladrey LLC, a Delaware limited liability company (together with Borrower, the "Grantors") granted a security interest in the United States trademarks listed in Exhibit A attached hereto and in the other collateral described in the Confirmatory Grant (as defined below) (collectively, the "Collateral") to U.S. BANK NATIONAL ASSOCIATION, a national banking association (the "Grantee"), in order to secure repayment of certain amounts owing to Grantee and the other lenders (the "Lenders") from time to time party to that certain Credit Agreement dated November 30, 2011 among the Borrower, the Grantee, and the Lenders, as amended, restated, or otherwise modified from time to time (the "Credit Agreement");

WHEREAS, a Confirmatory Grant of Security Interest in United States Trademarks (the "Confirmatory Grant") between the Grantors and the Grantee with respect to the marks listed in Exhibit A was entered into on November 30, 2011, and was recorded in the records of the United States Patent and Trademark Office (the "USPTO") on December 2, 2011, and such recordation is located on Reel 4671 at Frame 0813 of the USPTO; and


WHEREAS, the Grantee desires to release the marks listed in Exhibit A from the Confirmatory Grant.

NOW THEREFORE, to all who it may concern be it known that for and in consideration of the payment to the Grantee of the full amount of the indebtedness described in the Credit Agreement and Confirmatory Grant, the Grantee hereby (a) releases and discharges all the security interests granted by the Confirmatory Grant, being the security interests granted in respect of the patents, trademarks, copyrights and all other Collateral and (b) acknowledges, confirms and agrees that the Confirmatory Grant is discharged, released and terminated and of no further force or effect.
