MASTER TRADEMARK LICENSE AGREEMENT

This Master Trademark License Agreement (as amended, restated, supplemented or otherwise modified from time to time, this “*Agreement*”), dated and effective as of June 24, 2014 (“*Effective Date*”), is by and between Playboy Enterprises International Inc., a Delaware corporation having an address of 9346 Civic Center Dr., #200, Beverly Hills, California 90210 (“*Licensor*”), and Products Licensing LLC, a Delaware limited liability company having an address of 9346 Civic Center Dr., #200, Beverly Hills, California 90210 (“*Licensee*”) (Licensor and Licensee, each a “*Party*”, and collectively, the “*Parties*”).

WHEREAS, Licensor is the sole and exclusive owner of all right, title, interest and goodwill in and to the trademarks, service marks, logos, and applications and registrations therefor as set forth in **Schedule A** attached hereto, as may be amended or modified from time to time by the parties (collectively, “*PLAYBOY Marks*”);

WHEREAS, Licensor is a party to certain trademark license agreements (as the licensor) with various third parties concerning the PLAYBOY Marks for use in connection with the manufacture, distribution and sale of certain products and/or provision of certain services (as amended, restated, supplemented or otherwise modified from time to time, collectively, the “*Third Party License Agreements*”), and Licensee, through the Master Assignment Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the “*Assumption Agreement*”), has assumed and, in the future, shall assume Licensor’s obligations and responsibilities under such Third Party License Agreements and all Future Third Party License Agreements (as defined in the Assumption Agreement);

WHEREAS, Licensee, including pursuant to the Assumption Agreement, intends to engage in the business of sublicensing to third parties the right to use the PLAYBOY Marks for the manufacture, distribution and sale, and the provision of certain products and/or services worldwide; and

WHEREAS, to permit Licensee to assume the Third Party License Agreements and Future third Party License Agreements and perform the obligations and responsibilities of Licensor thereunder, and to sublicense third parties the right to use the PLAYBOY Marks, Licensor hereby desires to grant to Licensee and Licensee hereby desires to obtain from Licensor, a license to sublicense the PLAYBOY Marks under the terms and conditions of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the Parties agree as follows:

1. *Exclusive License.* Licensor hereby grants to Licensee and Licensee hereby accepts a worldwide, exclusive license to the PLAYBOY Marks (and each of them) in connection with the following, in each case subject to Section 1(c):
 - (i) Licensee’s assumption and performance under the Third Party License Agreements;

- (ii) Licensee's execution and performance under Future Third Party License Agreements, provided that, upon agreement by the Parties, Licensor may enter into and execute Future Third Party Licenses Agreements, in each case, in the name of and solely as an agent for the Licensee;
- (iii) to sublicense (whether on an exclusive or non-exclusive basis) the manufacture, distribution, and/or sale of one or more classes of Consumer Products;
- (iv) to sublicense (whether on an exclusive or non-exclusive basis) the manufacture, distribution, and/or sale of one or more Gambling Products; and
- (v) to market, promote, and brand any or all of the PLAYBOY Marks (except with respect to Excluded Products), and to sublicense any one or more of the PLAYBOY Marks for use in connection with LBEs.

All sublicenses granted by Licensee hereunder shall be subject to quality control provisions, which shall be at least as restrictive as the quality control provisions found in Section 3 of this Agreement, or as otherwise agreed to by the Parties.

- a. *Prohibited Use.* Notwithstanding anything herein to the contrary, licenses granted in Section 1 hereinabove do not include the right for Licensee to: (i) use any PLAYBOY Marks on products or services offered directly by Licensee on its own (Licensee only has the right to sublicense the PLAYBOY Marks); (ii) make any material alterations of the PLAYBOY Marks or create derivative works based on any PLAYBOY Marks; or (iii) file for or obtain any trademark, trade name, or domain name registrations for the PLAYBOY Marks or any marks or names confusingly similar thereto.
- b. *Definitions.* As used in this Agreement, the following definitions shall apply:

"Consumer Products": means tangible merchandise sold at retail (both physical stores and through e-commerce sites) for purchase by the general purchasing public (*e.g.*, apparel, jewelry, accessories, bags, etc.) that is branded with, or promoted using, any one or more of the PLAYBOY Marks, but expressly excluding the Excluded Products.

"Excluded Products": Consumer Products, LBE and Gambling Products shall not cover, include, or extend to any of the following:

- (i) The operation of domestic and international networks and premium pay television services (including, without limitation, the production, provision and/or delivery of programming to cable system operators, satellite distribution services, telephone companies, Internet Protocol Television systems, mobile operators, broadband and other distribution platforms and outlets) and websites and digital applications associated with such networks and pay television services.

- (ii) The production, distribution and/or licensing of print and digital editions of magazines, e-Zines, newspapers, books, publishing and publishing related ventures, including, without limitation, digital storefronts, websites and digital applications associated with such magazines, e-Zines, newspapers, books and other publishing and publishing related ventures; and other publishing applications traditionally exploited by Playboy in its media and/or publishing business (whether distributed in physical form or digitally), including, without limitation, the distribution and licensing of merchandise for promotional or marketing purposes in connection therewith.
- (iii) The production, distribution and/or licensing of content and media assets, including, without limitation, motion pictures, video, music, photographs, images, and other entertainment and media assets and audio/visual works, television programming, animation, and other video products and the operation of websites and digital applications associated with the foregoing (other than Gambling Products) or other entertainment applications traditionally exploited by Playboy in its media and/or publishing business (whether distributed in physical form or digitally), distributed through any trade channels and product format currently in existence or developed in the future, whether directly by or with wireless carriers, distributors and OEM's or otherwise, including, without limitation, the distribution and licensing of merchandise for promotional or marketing purposes in connection therewith; and the sale, licensing and/or distribution of content on *DVD* and Blu-Ray discs, video on demand, electronic sell through, applications for mobile devices, ring tones, ring-back tones/themes, wall papers for mobile devices, social media, applications for all types of wireless communication or handheld devices (including, without limitation, phones, tablets, the IOS and Android operating systems, and other similar platforms developed in the future), the Internet or other digital services.
- (iv) Any live event or other event or location that would otherwise be included within the definition of LBE if the live event or other event or location is not open to the public for more than fourteen (14) continuous days or four (4) contiguous weekends.

“Gambling Products”: means gambling and gaming equipment, devices, and platforms (whether physical, mechanical, or provided via electronic/video medium) on which a wager is placed or which facilitate wagering and that have monetary payouts or other compensatory returns, or any such equipment, devices, and platforms, which provide for-fun/entertainment gaming experience without any monetary payouts or other compensatory returns, that is branded with, or promoted using, any one or more of the PLAYBOY Marks, but expressly excluding the Excluded Products.

“LBE”: means any lodging, restaurant, concert, nightclub, casino, hotel, theme park, resort or attraction, location-based entertainment center, cruise

ship or similar events or facility that is branded with or promoted under the PLAYBOY Marks, but expressly excluding the Excluded Products.

- c. *Licensor's Retained Rights.* For the avoidance of doubt, the Parties agree that the foregoing license granted to Licensee shall not impact or affect in anyway, Licensor's right or ability to use any of the PLAYBOY Marks (on behalf of itself and its subsidiaries and affiliated companies, and third parties) in connection with Excluded Products and/or the marketing and/or sale of any other goods or services (not including Consumer Products, Gambling Products and LBEs) through any distribution or trade channels worldwide.
 - d. *Recordation.* The Parties agree and acknowledge that this Agreement may be filed with the intellectual or industrial property office, or other governmental offices, as necessary to comply with local laws. All costs associated with such filing shall be the sole responsibility of Licensee.
2. *Trademark Ownership.* Licensee acknowledges and confirms Licensor's exclusive ownership of the PLAYBOY Marks and all rights, including intellectual property rights, in and to such marks, and further acknowledges and agrees that all goodwill attached to the PLAYBOY Marks by Licensee hereunder shall inure to the exclusive benefit of Licensor. Further Licensee shall provide full cooperation upon Licensor's request to enable Licensor to file for or maintain/renewal any applications or registrations for the PLAYBOY Marks.
3. *Quality Control.* Licensor shall, at all times, have the right, in its sole discretion, to determine if the use of the PLAYBOY Marks by Licensee or any sublicensee is compliant with the terms and conditions of this Agreement, including, without limitation, whether the products and/or services that are and/or proposed to be offered under the PLAYBOY Marks by Licensee meet the level of quality established by Licensor ("*Acceptable Quality Standards*").
- a. To assure continued compliance with the Acceptable Quality Standards, Licensee shall make available to the Licensor or its designee, upon reasonable notice and with reasonable frequency, information and materials relating to the use of the PLAYBOY Marks, including examples of use.
 - b. Licensor may from time to time, provide Licensee with certain materials which sets forth guidelines concerning the use of the PLAYBOY Marks. Licensee shall, at all times conform, and shall cause all of its sublicensees to conform, to such guidelines to Licensor's satisfaction.
 - c. Upon notice ("*Notice*") from Licensor that Licensee's use of the PLAYBOY Marks does not comply with the Acceptable Quality Standards, Licensee shall, within ninety (90) days after receipt of the Notice or as otherwise agreed to by the Parties, correct its use of the PLAYBOY Marks to comply with the Acceptable Quality Standards.
4. *Term and Termination.* The term of the License shall be effective as of the Effective Date and shall continue for ninety-nine (99) years therefrom ("*Term*"). Thereafter,

upon the expiration of the Term, this Agreement shall terminate automatically without any further action by either Party, provided that the Parties have not agreed to renew the Agreement in writing.

5. *Default/Breach.* A Party will be in default under this Agreement if said Party violates any material provisions of this Agreement and such violation is not cured within ninety (90) days (“*Cure Period*”) of its receipt of written notice of such violation. A copy of any notice of default to Licensee shall concurrently be given in writing to any financier to Licensee who at any time expressly requests a copy of such notice in writing, and any such financier shall have the right, in addition to, or in lieu of, Licensee, to effectuate a cure of any default during the Cure Period. In such event of default for non-cure, the non-defaulting Party shall have the right to terminate this Agreement by providing the defaulting Party with written notice of termination. Upon such termination, however, the defaulting Party shall not be relieved of any of its obligations under this Agreement.
6. *Representations by Licensor.* Licensor represents and warrants that, as of the date hereof: (i) it owns the PLAYBOY Marks free and clear of all liens, except for Permitted Liens (as defined in the Credit Agreement Among Products Licensing LLC and Lender’s Party Thereto and DBD Credit Funding LLC, as Administrative Agent (“*Agent*”), dated as of the date hereof, as amended, restated, supplemented or otherwise modified from time to time); (ii) it has not granted any third parties any rights to use the PLAYBOY Marks other than pursuant to Third Party License Agreements, agreements for the Excluded Products or Licensor’s retained rights as described hereinabove; (iii) all of the trademarks licensed pursuant to Third Party License Agreements that constitute Material Agreements (as defined in the Credit Agreement) are PLAYBOY Marks; and (iv) it has the right and authority to enter into and grant the rights licensed to Licensee under this Agreement.
7. *Covenant of Licensor.* Licensor agrees that, as of each date that Licensee is required to deliver a “Compliance Certificate” pursuant to Section 5.01(c) of the Credit Agreement referred to in Paragraph 6 above in connection with the delivery of quarterly financial reporting pursuant to Section 5.01(b) of the Credit Agreement, Licensor deliver to Licensee an updated version of Schedule A to this Agreement (provided that, if there have been no changes to such Schedule since the previous updating thereof as required hereby, Licensor shall provide written notice to Licensee that there have been no changes to such Schedule).
8. **DISCLAIMER OF WARRANTIES. THE PARTIES AGREE AND ACKNOWLEDGE THAT, EXCEPT AS OTHERWISE EXPRESSLY REPRESENTED AND WARRANTED IN SECTION 6, THE PLAYBOY MARKS ARE BEING LICENSED HEREIN AS-IS AND LICENSOR EXPRESSLY DISCLAIMS ALL WARRANTIES, EXPRESS OR IMPLIED, IN RELATION TO SUCH MARKS, INCLUDING ANY WARRANTY OF NON-INFRINGEMENT. IN NO EVENT SHALL LICENSOR OR ITS AFFILIATES, CONTRACTORS, AGENTS, OFFICERS, OR EMPLOYEES, BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES INCURRED BY LICENSEE OR ANY THIRD**

PARTY RESULTING FROM LICENSEE'S USE OF THE PLAYBOY MARKS OR EXERCISE OF THE LICENSE GRANTED HEREIN.

9. *Indemnity.* Licensee shall, to the extent necessary, indemnify, defend and hold harmless Licensors, its subsidiaries and affiliates, their respective shareholders, licensees and franchisees and the agents, officers, directors and employees of each and Licensors's agents from all costs, claims, suits, losses, damages and expenses (including without limitation attorneys' fees and litigation or other expenses) arising out of or in connection with: (i) Licensee's exercise of the license granted herein; (ii) any alleged action or failure to act whatsoever by Licensee; (iii) any alleged defect in any or all of the Consumer Products; (iv) any alleged non-conformity to or non-compliance with any law pertaining to the design, quality, safety, advertising, promotion or marketing of any or all of the Consumer Products; (v) any sales or distribution by any of Licensee's sublicensees of the Consumer Products to a country where a third party owns the registrations for trademarks that are confusingly similar to the PLAYBOY Marks; (vi) any breach by Licensee of his Agreement or any representations and warranties made by Licensee; or (vii) Licensee's performance hereunder.
- (b) Licensors shall, to the extent necessary, indemnify, defend and hold harmless Licensee, its subsidiaries and affiliates, their respective shareholders, licensees and franchisees and the agents, officers, directors and employees of each and Licensee's agents from all costs, claims, suits, losses, damages and expenses (including without limitation attorneys' fees and litigation or other expenses) arising out of or in connection with any breach by Licensors of his Agreement or any representations and warranties made by Licensors.
10. *Assignment.* Licensors may freely assign this Agreement, in whole or in part, to any party. The present Agreement and all the rights granted herein are personal to Licensee and Licensee shall not, without Licensors's prior written consent (except that Licensee may collaterally assign this Agreement, and all its rights hereunder to Agent, and Agent may, under the circumstances provided in the Credit Agreement and/or any security documents executed in connection therewith, exercise the rights of Licensee hereunder) and except as expressly permitted herein, assign, transfer, or convey this Agreement and/or any rights granted herein to any third party, including by operation of law or change of control (comprising the sale or conveyance of majority equity or controlling shares or interest of Licensee to a third party). Any such attempt to assign, transfer, or convey, shall be deemed *void ab initio* and constitute a material breach of this Agreement.
11. *Severability.* Each provision of this Agreement shall be severable. If, for any reason, any provision herein is finally determined to be invalid and contrary to, or in conflict with, any existing or future law or regulation by a court or agency having valid jurisdiction, such determination shall not impair the operation or affect the remaining provisions of this Agreement, and such remaining provisions will continue to be given full force and effect and bind the parties hereto. Each invalid provision shall be curtailed only to the extent necessary to bring it within the requirements of such law or regulation.


12. *No Fiduciary Duty.* Nothing herein contained shall be construed to place the Parties hereto in the relationship of partners or joint venturers, and Licensee shall have no power to obligate or bind Licensor or its subsidiaries or affiliates in any manner whatsoever, and Licensor will have no fiduciary duty or fiduciary obligation to Licensee or any other third parties under this Agreement.
13. *Amendments.* The provisions of this Agreement shall be binding upon and inure to the benefit of the Parties and their respective successors and permitted assigns. This Agreement may not be altered or amended in any manner except by express agreement signed by the Party against whom the enforcement of such change is sought. Unless specifically agreed to the contrary in writing, the failure by Licensor at any time to require performance by the other of any provision of this Agreement shall not affect Licensor's right thereafter to enforce such provision. The Parties agree to execute, acknowledge and/or deliver any and all additional documents that may be reasonably requested or deemed by the other Party as necessary to evidence and effectuate any and all of the rights granted under this Agreement and do all such things as may be necessary and proper to carry out and effectuate the intent and purpose of this Agreement.
14. *Completeness and Interpretation.* This Agreement sets forth the entire understanding and agreement between the Parties as to the matters covered in this Agreement and supersedes and replaces any prior understanding, agreement or statement of intent, in each case, written or oral, of any and every nature with respect to such understanding, agreement or statement. The headings used herein are for convenience only and shall not be deemed to define, limit or construe the contents of any provision of this Agreement. The wording of this Agreement will be deemed to be the wording chosen by the parties hereto to express their mutual intent, and no rule of strict construction will be applied against any such party. The Schedule, Recitals and all Exhibits attached hereto shall be deemed to be part of this Agreement. This Agreement may be executed in separate counterparts, each of which is deemed to be an original, and all of which taken together constitute one and the same agreement.
15. *Choice of Law.* This Agreement shall be governed by and interpreted under the laws of the State of California without regard to its conflicts of laws provisions. Licensee hereby submits to personal jurisdiction in Los Angeles, California or any other court of competent jurisdiction chosen by Licensor. The parties hereto agree that any and all disputes arising out of or relating in any way to this Agreement shall be litigated only in courts sitting in Los Angeles, California or any other court of competent jurisdiction chosen by Licensor.
