**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of June 30, 2014, is made by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") pursuant to the Credit Agreement, dated as of September 27, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement") and the Guaranty and Security Agreement, dated as of September 27, 2010 (the "Security Agreement"). Capitalized terms not otherwise defined herein have the meaning assigned to them in the Security Agreement.

WITNESSETH

WHEREAS, Medical Staffing Network Healthcare, LLC (the "Grantor") is a party to the Credit Agreement and the Security Agreement;

WHEREAS, pursuant to the Credit Agreement and the Security Agreement, the Grantor executed the Trademark Security Agreement dated September 27, 2010 and recorded with the U.S. Patent and Trademark Office on November 5, 2010 at Reel/Frame No. 4410/0514 (the "Trademark Security Agreement"), pursuant to which the Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Grantor has requested that the Administrative Agent release its Lien on and security interest in and to that portion of the Trademark Collateral set forth Schedule I attached hereto (the "Released Collateral").


NOW, THEREFORE, the Administrative Agent, on its own and on behalf of the Secured Parties, hereby relinquishes, terminates, cancels and releases, without recourse, any and all right, title and interest it may have, or have acquired through the Credit Agreement, Security Agreement, and Trademark Security Agreement or otherwise, in the Released Collateral.

The Administrative Agent agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of its Lien on and security interest in the Released Collateral.
