**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY dated as of June 30, 2014 (“Release”) is made by U.S. BANK NATIONAL ASSOCIATION, in its capacity as Administrative Agent (the “Administrative Agent”) under that certain Credit Agreement dated as of January 24, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among QCE LLC (“Borrower”), QCE FINANCE LLC (“Holdco”), the lenders party thereto and the Administrative Agent.

WHEREAS, on or about January 24, 2012, pursuant to that certain Intellectual Property Security Agreement (as amended, the “Intellectual Property Security Agreement”) in favor of the Administrative Agent, QIP HOLDER LLC and THE QUIZNO’S MASTER LLC (the “Grantors”), pledged and granted to the Administrative Agent for itself and the benefit of certain secured parties, a security interest in and to all of the Grantors’ right, title and interest in Grantors’ intellectual property, including each intellectual property registration or application referred to in Schedule A (collectively, the “Intellectual Property”), which security interest was recorded in the records of the United States Patent and Patent Office at Trademark Reel 4846, Frame 0355;

WHEREAS, the Effective Date (as defined in that certain Joint Prepackaged Chapter 11 Plan of Reorganization, dated as of March 14, 2014 and filed by the Borrower, the Grantors and the other debtors with the United States Bankruptcy Court for the District of Delaware on March 14, 2014, as supplemented by the Plan Supplement (as defined in the Plan), the “Plan”) occurred on June 30, 2014 and, pursuant to Section 4.12 of the Plan, on the Effective Date, all liens securing the obligations under the Credit Agreement are deemed released;

WHEREAS, pursuant to Section 4.12 of the Plan, the Administrative Agent is authorized and directed to release any collateral or other property (including any right, title and interest in and to the Intellectual Property) of any debtor (including the Grantors) held by the Administrative Agent and to take such actions as may be requested by the debtors (including the Grantors) to evidence the release of any such lien, including the execution, delivery and filing or recording of such releases as may be requested by the debtors (including the Grantors); and

WHEREAS, the Administrative Agent has agreed to: (i) release its security interest covering the Intellectual Property; (ii) restore all right, title and interest in and to the Intellectual Property to the Grantors; and (iii) dissolve any and all liens and encumbrances respecting the Intellectual Property under the Intellectual Property Security Agreement or otherwise.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. The Administrative Agent hereby releases and terminates in its entirety its security interest in, and discharges, quit claims and relinquishes unto the Grantors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to, the Intellectual Property and all products and proceeds thereof.

2. The Administrative Agent hereby authorizes each Grantor or its authorized representative to (a) record this Release with the United States Patent and Trademark Office and (b) file Uniform Commercial Code termination statements with the applicable filing office in order to memorialize the release of any security interest of the Administrative Agent in the Intellectual Property.


3. The Administrative Agent hereby agrees to take any actions and to execute any further documents necessary or reasonably requested, in writing, by the Grantors, at the Grantors' sole cost and expense, to effectuate or evidence such release.

4. This Release and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
