The assignment granted herein has been granted in accordance with the terms of a separate purchase agreement between the parties and is expressly subject to the terms thereof.

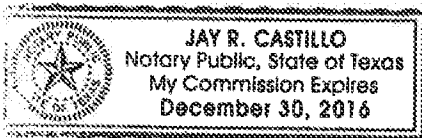
