WHEREAS, Assignor and Assignee have entered into that certain First Amendment to Amended and Restated Trademark Security Agreement dated July 24, 2013;

WHEREAS, Assignor and Assignee have entered into that certain Second Amendment to Amended and Restated Trademark Security Agreement dated June 30, 2014 (the "Second Amendment"); and

WHEREAS, pursuant to the Second Amendment, Assignor agreed to enter into this Assignment for Security (Trademarks).

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Assignor does hereby grant to the Assignee a lien on and security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Collateral are more fully set forth in the Security Agreement, as amended by the Amendment, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
