Assignor shall not be responsible for recording this Trademark Assignment with the U.S. Patent and Trademark Office, or for any fees or expenses related to the recordation of this Trademark Assignment.


This Trademark Assignment shall be binding upon Assignor and inure to the benefit of Assignee and its successors and assigns.
