RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of June 3, 2014 (this "Release"), is made by JPMORGAN CHASE BANK, N.A., as Administrative Agent (in such capacity, "Agent") under the Pledge and Security Agreement described below, in favor of TROON GOLF, L.L.C., a Delaware limited liability company (the "Debtor") as follows:

NOW, THEREFORE, Agent, at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and all right, title and interest of the Agent or the other Lenders in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide the Debtor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the released Trademark Collateral at the Debtor's sole cost and expense.
