**RELEASE OF SECURITY INTEREST
IN SELECTED TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN SELECTED TRADEMARK COLLATERAL, dated as of July 1, 2014 (this "Release"), is made by JPMorgan Chase Bank, N.A., in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent") in favor of Musictoday, LLC, a Virginia limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto or otherwise referenced in the Security Agreement (as defined below).

W I T N E S S E T H

WHEREAS, pursuant to those certain Trademark Security Agreement, dated as of May 6, 2010 (the "Security Agreement"), the Grantor granted the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in and to the Applicable Collateral (as defined therein);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on May 12, 2010 at Reel/Frame 4204/0353;

WHEREAS, pursuant to that certain Release of Guarantor, dated as of July 1, 2014, by and between JPMorgan Chase Bank, N.A., in its capacity as Secured Party (as defined therein) to Live Nation Entertainment, Inc., a Delaware corporation (the "Release of Guarantor"), the Grantor requested that the Collateral Agent release its security interest in all right, title and interest of the Collateral Agent in the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Collateral") and reconvey any and all rights it may have in the Released Collateral to the Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

SECTION 1. The Collateral Agent hereby, without representation, warranty or recourse of any kind: (i) terminates, cancels, discharges, and releases its security interest in all of the Grantor's right, title and interest in the Released Collateral; and (ii) re-assigns to the Grantor any and all interest it may have in such Released Collateral. For the avoidance of any doubt, this Release is limited solely and only to the Released Collateral and to no other Applicable Collateral under the Security Agreement, and the Collateral Agent's security interest in such other Applicable Collateral shall not be impaired, interrupted or otherwise modified in any respect.


SECTION 2. The Collateral Agent hereby authorizes Grantor, or Grantor's authorized representatives to record this Release with USPTO and/or any other applicable governmental office or agency. The Collateral Agent agrees, upon the reasonable request of the Grantor, and at the Grantor's sole cost and expense, to execute, acknowledge and deliver any additional documents or instruments and take any additional actions necessary or as may be necessary to effect, record and perfect the release of the Collateral Agent's security interest in the Released Collateral which had been granted under the Security Agreement.
