TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 2, 2014, is made by Wells Fargo Capital Finance, LLC (successor in interest to Wells Fargo Foothill, LLC), as Agent for the Lender Group and the Bank Product Providers (together with its successors and assigns, the "Agent"). All capitalized terms used herein but not defined herein shall have the respective meanings ascribed to them in the Trademark Security Agreement (as defined below).

WHEREAS, True Commerce Inc., a Delaware corporation, (the "Grantor") has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain trademarks and trademark applications ("Trademarks"), pursuant to that certain Trademark Security Agreement dated as of October 8, 2010 (the "Trademark Security Agreement");

WHEREAS, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office as follows: on October 12, 2010 at Reel 4294 and Frame 0566;

WHEREAS, the Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Trademark Security Agreement and hereby terminates and releases all mortgages, liens, and security interests granted to the Agent in the following:

1. all of the Trademarks including those referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark;
3. all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark; and
4. all other Trademark Collateral.
