RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of July 2, 2014, by Silicon Valley Bank ("Bank") in favor of IASTA.COM, INC., an Indiana corporation, IASTA EXPORT CORPORATION, a Delaware corporation and IASTA RESOURCES, INC., an Indiana corporation (collectively "Company") with their principal place of business at 12800 North Meridian Street, Suite 425, Carmel, IN 46032.

Recital

WHEREAS Company granted a security interest in the trademarks and copyrights listed on Exhibits A and B, respectively, attached hereto (collectively, the "Intellectual Property") to Bank under an Intellectual Property Security Agreement dated as of February 8, 2012 and an Addendum to Intellectual Property Security Agreement dated as of January 30, 2013 (collectively, the "IP Security Agreement") which security interest in such trademarks was recorded with the US Patent and Trademark Office as indicated on Exhibit A.
