SECOND LIEN TRADEMARK SECURITY AGREEMENT

This Second Lien Trademark Security Agreement (this "Trademark Security Agreement"), dated as of July 1, 2014 by SiTV, LLC, formerly known as SiTV, Inc., a Delaware limited liability company (the "Company"), and Fuse Networks LLC, a New York limited liability company (each, a "Pledgor" and collectively, the "Pledgors"), and Wilmington Trust, National Association, in its capacity as Collateral Agent (in such capacity, the "Collateral Agent") pursuant to the Indenture, dated as of July 1, 2014, among the Company and SiTV Finance, Inc., as issuers, the Guarantors party thereto, the Trustee and the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Indenture").

W I T N E S S E T H:

WHEREAS, each Pledgor is a party to a Security Agreement of even date with the Indenture (the "Security Agreement") in favor of the Collateral Agent pursuant to which each Pledgor is required to execute and deliver this Trademark Security Agreement.

NOW, THEREFORE, in consideration of the premises and to induce the Collateral Agent, for the ratable benefit of the Secured Parties, to enter into the Indenture, each Pledgor hereby agrees with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Each Pledgor hereby pledges and grants to the Collateral Agent for the ratable benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following Collateral of each such Pledgor (collectively, the "Trademark Collateral"):

- (a) all Trademarks of each such Pledgor, including as listed on Schedule 1 attached hereto;
- (b) all goodwill associated with such Trademarks;
- (c) all Proceeds of any and all of the foregoing (other than Excluded Assets); and
- (d) all causes of action arising prior to or after the date hereof for infringement of any of the trademarks or unfair competition regarding the same.

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Security Agreement, and each Pledgor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 4. Termination. Upon the full payment and performance of the Secured Obligations (other than contingent indemnification obligations for which no claim or demand has been made and that, pursuant to the provisions of the Indenture or the Collateral Documents, survive the termination thereof), upon written request of a Pledgor, the Collateral Agent shall (at such Pledgor's sole cost and expense)

execute, acknowledge, and deliver to that Pledgor an instrument in writing in recordable form prepared by such Pledgor releasing the collateral pledge, grant, assignment, lien and security interest in such Pledgor's Trademarks under this Trademark Security Agreement.
