RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST, dated as of June 24, 2014 ("**Release**"), is made by and between SUSQUEHANNA BANK, a bank organized and existing under the laws of the Commonwealth of Pennsylvania and successor by merger to COMMUNITYBANKS, having an address of 1570 Manheim Pike, Lancaster, Pennsylvania 17601 ("**Bank**"), in favor of Furman Foods, Inc., a Pennsylvania corporation having an address of P. O. Box 500, Northumberland, Pennsylvania 17857 ("**Furman**"), with respect to a certain Security Agreement dated October 29, 2007, which has been recorded in the records of the United States Patent and Trademark Office at Trademark Reel 003655, Frame 0446 (the "Security Agreement").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, Furman granted to Bank a security interest in certain of Furman's Trademarks, including those set forth on Schedule A hereto, and the registrations therefor and the goodwill of Furman's business symbolized thereby (the "**Trademark Collateral**"); and

WHEREAS, Bank, in favor of and for the benefit of Furman, wishes to: (i) release all of its security interest covering the Trademark Collateral; (ii) revoke any assignments of the Trademark Collateral that would have been caused by the Security Agreement; (iii) restore all right, title and interest in and to the Trademark Collateral to Furman; and (iv) to dissolve any and all liens and encumbrances with respect to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, specifically, the Payoff Amount as defined in that certain Payoff Letter from Bank to Furman dated June 17, 2014, the receipt of which is hereby acknowledged, Bank hereby releases its security interest in the Trademark Collateral, revokes any assignments of the Trademark Collateral effectuated by the Security Agreement and assigns, discharges, quit claims and relinquishes to Furman (in each case without recourse and without any representation or warranty) any and all right, title and interest it may have in and to the Trademark Collateral.

IN WITNESS WHEREOF, Bank has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the day and year first above written.
