Assignor does hereby assign, transfer, convey and set over unto Assignee its full rights, title and interests in the U.S. in, to and under the Assigned Marks, together with the goodwill of the business symbolized by said Assigned Mark, and the U.S. trademark applications or registrations therefor, any renewal rights therein, and the exclusive right to enforce the Assigned Marks in the U.S. in the sole name of Assignee, its successors and assigns; the aforesaid transferred rights, title and interests to be held and enjoyed by Assignee, its successors, legal representatives and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment not been made.
