TRADEMARK ASSIGNMENT AGREEMENT

30 THIS TRADEMARK ASSIGNMENT (the "Assignment") is made effective as of the day of June 2014, by Pappas Telecasting Companies, a California corporation ("Assignor"), for the benefit of Pappas Radio of California, A California Limited Partnership ("Assignee").

WHEREAS, Assignor is the record owner in the U.S. Patent and Trademark Office of the trademark identified by Registration Number 3471607, for the mark "KTRB", including all common law rights thereto (the "Trademark"), and the goodwill of the business symbolized thereby (see more detailed information on Exhibit A);

WHEREAS, Assignee is the FCC licensee of commercial radio station KTRB;

WHEREAS, Assignor agrees to assign its entire right, title and interest in and to the Trademark to Assignee; and

WHEREAS, Assignee agrees to acquire Assignor's entire right, title and interest in and to the Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. The consideration to be paid by Assignee to Assignor concurrently with the Assignment for the sale and assignment of the Trademark as provided herein shall be **Two Thousand Dollars (\$2,000.00)** (the "Purchase Price"). The Purchase Price shall be paid to Assignor concurrently with the execution of this Agreement by check for immediately available U. S. dollars.
2. The Assignor is the record owner of the Trademark and hereby sells, assigns, transfers and conveys unto Assignee, absolutely and forever, all of its rights, title and interests in and to the Trademark, whether statutory or at common law together with the goodwill of the business symbolized by the Trademark, as well as all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements other than an action for dilution of the mark in conjunction with an action designed to uphold the record of Assignor.
3. The Trademark is subsisting and has not been adjudged invalid or unenforceable, in whole or in part.
4. Following execution of this Agreement, the parties shall file a Trademark Assignment Application with the U.S. Patent and Trademark Office. Assignee shall be responsible for the payment of the filing fee associated with such application.
5. Assignor authorizes the U.S. Patent and Trademark Office to issue any and all trademark registrations, amended registrations and/or renewals that may be granted upon any application or petition for same, to Assignee, and/or Assignee's successors and/or assigns.


