Exit Agreement between Ana Johnson and Juliann Donnelly

This Exit Agreement consists of Four (4) pages, including Two (2) Notarized Pages

As per Ana Johnson's email dated January 22, 2014, the Julana Enterprises partnership between Juliann (Julie) Donnelly and Ana Johnson is dissolved effective January 22, 2014.

Juliann Donnelly releases Ana Johnson from any of TriggerPoint Yoga financial obligations and legal liabilities that may occur after the date of closure on January 22, 2014.

The Julana Enterprises Partnership, publically called "TriggerPoint Yoga," has been closed in Texas and all taxes for 2013 and prior years have been paid in full.

Ana Johnson has freely and completely released her 50% interest in the Julana Enterprises Partnership and TriggerPoint Yoga.

Ana Johnson invested \$33,027.00 (Final Debt) into the development and product inventory of Julana Enterprises and TriggerPoint yoga. 50% of the Final Debt (\$16,500.00) will be accepted by Juliann Donnelly as the "buy out" of Ana Johnson's Partner Interest in the Julana Enterprises partnership and TriggerPoint Yoga as described in paragraph below.

As agreed, payment of the Final Debt of \$16,500.00 will be made from 20% of the net sales of the Upper Body and Lower Body DVDs, including the Digital Version of TriggerPoint Yoga. Payments will be made every quarter until the \$16,500.00 obligation has been paid in full.

Juliann Donnelly agrees to pay 50% of "Surrender of Loan" penalty on the amount of 33,027.00. Planned date of Surrender of Loan is April 15, 2016. The penalty amount has not yet been confirmed. It is agreed that the penalty amount is not to exceed \$2500.00 for Juliann Donnelly.

Ana Johnson and Juliann Donnelly agree that this is a fair and final compensation for the final exit agreement and "Buy Out" of Julana Enterprises and TriggerPoint Yoga.

In order for TriggerPoint Yoga to move forward, Ana Johnson recommended JoAnne Schaub to fill the role of yoga teacher.

With the release and closure of Julana Enterprises DBA TriggerPoint Yoga, Juliann Donnelly has organized and registered TriggerPoint Yoga LLC as a new company in Bradenton, FL

Ana Johnson has no claim to future TriggerPoint Yoga LLC income or profits. Pricing for the aforementioned DVDs is at the discretion of TriggerPoint Yoga LLC, with the understanding that the price will always be at fair market value, excluding promotional discounts to broaden marketing reach.

It is agreed that Ana Johnson has no claim of any type on the “Julstro” name or method or any products that have been or will be created in the future by Juliann Donnelly under the name of “Julstro”.

Ana Johnson retains full copyright for her photographs that were used in the creation of the TriggerPoint Yoga DVDs. If at any time TriggerPoint Yoga LLC would want the use of the photographs TriggerPoint Yoga LLC will only be allowed by requesting permission in writing.

Ana Johnson gives permission for TriggerPoint Yoga LLC to use her personal images on the website, blog, and social media pages.

Ana Johnson relinquishes all claims to the Julstro self-treatment techniques, recorded in the DVD named “The Foundation.” These techniques are taught in the TriggerPoint Yoga kit, consisting of The Foundation DVD, One Upper Body and One Lower Body DVD.

Ana Johnson has assigned the use of her creatively designed program combining Julstro self-treatments with Yoga postures, to TriggerPoint Yoga, LLC.



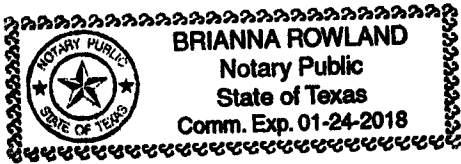


