## TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") by TQCGNA, Inc., an Ohio corporation with offices at 1505 Loveland Madeira Rd, Loveland, OH 45140 ("Assignor"), in favor of ABRA, INC., a Minnesota corporation with offices at 7225 Northland Drive, Brooklyn Park, MN 55428 ("Assignee"), is executed effective as of June 27, 2014.

### RECITALS

A. Assignor is the owner of the mark "CAR REPAIR FROM PEOPLE WHO CARE" together with U.S. Service Mark Reg. No. 4,380,178 and the mark "TRUE QUALITY" together with U.S. Service Mark Reg. No. 4,380,174 (each a "Mark" and collectively referred to herein as the "Mark").

B. This Assignment is being delivered in connection with an Asset Purchase Agreement dated June 3, 2014 (the "Asset Purchase Agreement"), by and among (A) Assignee ("Purchaser"); (B) TQC5, INC., an Ohio corporation; TQC8, LLC, an Ohio limited liability company; AKJK, LLC, an Ohio limited liability company; TQJJ, INC., an Ohio corporation; TQC9, LLC, an Ohio limited liability company; CGIK, LLC, an Ohio limited liability company; TQC11, LLC, an Ohio limited liability company; TQC7, INC., an Ohio corporation; JFJK, INC., an Ohio corporation; TQC6, INC., an Ohio corporation; JKJF, INC., an Ohio corporation; and TQC12, LLC, an Ohio limited liability company (each a "Seller," and collectively "Seller" or "Sellers"); and (C) JOHN KALLENBERGER and JERRY FRY (each an "Owner" and collectively the "Owners").

C. Assignor, an affiliate of Sellers, is wholly owned by the Owners and is required to deliver this Assignment in connection with the closing of the transactions contemplated by the Asset Purchase Agreement.

D. Assignor is executing this Assignment for recordation with the United States Patent and Trademark Office.

### AGREEMENT

In consideration of the above recitals and the promises set forth in this Assignment, the parties agree as follows:

Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Mark, together with all associated good will and all related rights, and all registrations and applications for registration of the Mark in the United States, including any renewals and extensions of any registration that is or may be secured. The provisions of this Assignment inure to the benefit of Assignee, its successors, assigns and other legal representatives, and are binding upon Assignor, its successors, assigns and other legal representatives.
