**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of July 8, 2014, is made by **CORTLAND PRODUCTS CORP.** f/k/a Broadpoint Products Corp., as administrative agent (the "Administrative Agent"), under the Trademark Security Agreement referred to below.

WHEREAS, Axia Acquisition Corporation, a Delaware corporation (the "Company") is a party to that certain Second Lien Security Agreement, dated as of March 12, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), made by the Company and the other pledgors named therein in favor of the Administrative Agent; and

WHEREAS, pursuant to (i) the Security Agreement and (ii) the Second Lien Trademark Security Agreement, dated as of March 12, 2010 (the "Trademark Security Agreement"), made by the Company in favor of the Administrative Agent, the Company granted to the Administrative Agent a security interest in the collateral described in Section 2 of the Trademark Security Agreement (the "Collateral"), including the trademarks, registrations and applications listed on Annex I attached hereto; and

WHEREAS, the Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on February 18, 2011, on Reel/Frame 4483/0279.

NOW THEREFORE, the Administrative Agent hereby releases, without representation, recourse or warranty whatsoever, its security interest in the Collateral granted pursuant to the Security Agreement and the Trademark Security Agreement, and the Administrative Agent hereby reassigns any and all such right, title and interest (if any) that the Administrative Agent may have in the Collateral to the Company.

The Administrative Agent agrees, at the Company's expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Administrative Agent's security interest in the Collateral.
