ASSIGNOR hereby covenants and agrees that it will at the request and expense of ASSIGNEE, execute or have executed any and all other instruments, and do all other acts which ASSIGNEE, its successors and assigns, may deem necessary or expedient in order to protect, and



ASSIGNEE agrees to defend and indemnify ASSIGNOR against costs incurred through claims of third parties against ASSIGNOR based on ASSIGNEE'S ownership of the Trademarks and/or the Registrations after the date of this Assignment.


