**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of July 10, 2014, is made by Deutsche Bank AG Cayman Islands Branch (“Lender”), in favor of UTGR, Inc. and Mile High USA, Inc. (individually and collective, the “Company”) as follows:

NOW, THEREFORE, Lender, without recourse, representation or warranty and at Company’s sole cost and expense, hereby RELEASES its security interest in, and continuing lien on, and ASSIGNS to the applicable Company, all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks set forth in Schedule A and any other collateral described in the Security Agreement.

LENDER agrees to provide Company with any information and additional authorization necessary to effect the release of Lender’s security interest in the Trademark Collateral.




