**PARTIAL TERMINATION OF SECURITY INTERESTS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:



2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.

The execution of this Termination by Secured Party shall not be construed to waive or in any way invalidate the lien of Secured Party (a) on the balance of the property described in the Security Agreement (other than with respect to the Released Trademarks and Patents) or (b) the liens granted pursuant to the other documents executed in connection therewith.
