ADDENDUM TO ASSET PURCHASE AGREEMENT

WHEREAS, Dwight C. Janisse & Associates, Inc. (hereinafter "Seller"), a Michigan corporation, on June 23, 2014 entered into an Asset Purchase Agreement wherein it agreed to sell certain assets to Entrepreneurial Pursuits, Inc. (hereinafter "Purchaser"), an Ohio corporation; and,
