INTELLECTUAL PROPERTY ASSIGNMENT

NOW THEREFORE, for good and valuable consideration, Company hereby assigns to Parent, all of (a) Company's entire right, title and interest, including the right to sue for and collect past damages and any other remedies, in and to the Assigned Patents, and any and all divisional applications, continuation applications, continuations-in-part, provisional applications, renewals, reissues, re-examinations, substitutions and extensions thereof, and all pending applications therefor, which claim priority from any application from which Assigned Patents are derived, as well as, all foreign counterparts of Assigned Patents, (b) Company's entire right, title and interest, including the right to sue for and collect past damages and any other remedies, in and to the Assigned Trademarks, and any and all registrations, applications, renewals and extensions related thereto, and all goodwill related to the foregoing; (c) Company's entire right, title and interest, including the right to sue for and collect past damages and any other remedies, in and to the Assigned Domain Names and all goodwill related to the foregoing; and (d) Company's entire right, title and interest, including the right to sue for and collect past damages and any other remedies, in and to the Unlisted IP and all goodwill related to the foregoing.


