RELEASE OF SECURITY INTEREST
IN TRADEMARKS

Dated as of July 14, 2014

Legend3D, Inc., a California corporation ("Grantor"), whose address is 2200 Faraday, Suite 100, Carlsbad, California 92008, executed a Trademark Security Agreement dated as of May 21, 2014 in favor of PAR Investment Partners, L.P., as collateral agent (the "Collateral Agent") (as amended from time to time, the "Security Agreement").

Collateral Agent wishes to release and retransfer to Grantor, without representation or warranty, all of Collateral Agent's right, title and interest in and to the Released Marks, and the goodwill associated therewith; *provided* that the provisions of this agreement will not in any way affect, terminate, release, retransfer or impair Collateral Agent's right, title and interest in and to all of the other trademark and servicemark rights, applications to register and registrations of the same listed on Schedule I to the Security Agreement.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, all of Collateral Agent's right, title and interest in and to the Released Marks, the goodwill associated therewith, and all causes of action for past infringement, if any.
