INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of July 2, 2014 (as amended, supplemented or otherwise modified from time to time, this "Intellectual Property Security Agreement"), is made by EWC P&T, LLC, a Florida limited liability company (together with its successors and assigns, the "Grantor"), in favor of SunTrust Bank, a Georgia banking corporation as secured party (together with its successors and assigns, "Secured Party").

WHEREAS, pursuant to a Security Agreement, dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, including in connection with any increase in the amount of any Obligations thereunder, the "Security Agreement"), among the Grantor, EWC Ventures, LLC, a Delaware limited liability company ("Borrower"), EWC Franchise, LLC, a Florida limited liability company ("EWC Franchise"), EWC Franchise Distribution, LLC, a Florida limited liability company ("EWC Franchise Distribution"), and EWC Ventures Stores, LLC, a Florida limited liability company ("EWC Ventures Stores"), (sometimes collectively, "Debtors") and Secured Party, the Grantor and each of the other Debtors have granted to Secured Party a security interest the Collateral described therein to secure all obligations ("Obligations") of Borrower to Secured Party under that certain Term Loan and Revolving Credit Agreement dated as of July 2, 2014, between Borrower and Secured Party (as amended, restated, supplemented or otherwise modified from time to time, including in connection with any increase in the amount of any Obligations thereunder, the "Credit Agreement"). Capitalized terms used and not defined herein have the meanings given such terms in the Security Agreement.

WHEREAS, it is a condition precedent to the undertaking of the Secured Party to make extensions of credit to the Borrower under the Credit Agreement that the Grantor shall have executed and delivered to Secured Party the Security Agreement.

WHEREAS, under the terms of the Security Agreement, the Grantor has granted a security interest in certain Collateral, including, without limitation, the Intellectual Property Collateral (as defined below) of the Grantor, and has agreed as a condition thereof to execute this Intellectual Property Security Agreement for recording with the United States Patent and Trademark Office, the United States Copyright Office, the appropriate Domain Name Registrar and any other applicable Governmental Authority.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees as follows:

SECTION 1. Grant of Security. The Grantor hereby confirms that it has granted to the Secured Party a security interest in and to all of the Grantor's right, title and interest in and to the following (the "Intellectual Property Collateral"), whether now existing or hereafter arising, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations:

(a) all trademarks (as described in the Security Agreement), including, without limitation, each registration and application identified in Schedule 1, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above (collectively, the "Pledged Trademarks");

(b) all domain names (as described in the Security Agreement), including, without limitation, each domain name identified in Schedule 1, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above (collectively, the "Pledged Domain Names");

(c) (i) all licenses or agreements, whether written or oral, providing for the grant by or to the Grantor of: (A) any right to use any Pledged Trademark, and (B) any right under any Pledged Domain Name, (ii) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations of any of the foregoing, (iii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iv) all other rights of any kind whatsoever of the Grantor accruing thereunder or pertaining thereto; and

(d) any and all proceeds of the foregoing.

SECTION 2. Recordation. The Grantor authorizes and requests that the Commissioner of Patents and Trademarks, the appropriate domain name registrar and any other applicable government officer record this Intellectual Property Security Agreement.

SECTION 3. Execution in Counterparts. This Intellectual Property Security Agreement may be executed in any number of counterparts (including by telecopy), each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Governing Law. This Intellectual Property Security Agreement shall be governed by, and construed and interpreted in accordance with, the law of the State of Florida.

SECTION 5. Conflict Provision. This Intellectual Property Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. The rights and remedies of each party hereto with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all terms and


provisions of which are incorporated herein by reference. In the event that any provisions of this Intellectual Property Security Agreement are in conflict with the Security Agreement or the Security Agreement, the provisions of the Security Agreement shall govern.



