TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made as of July 16, 2014, by and between AFFIRMA Rehabilitation Inc. (f/k/a Select Therapy, Inc.), a corporation organized and existing under the laws of California and having its principal place of business at 27071 Aliso Creek Drive, Suite 100, Aliso Viejo, California 92656 ("Assignor"), and Covenant Care California, LLC, a limited liability company organized and existing under the laws of Delaware and having its principal place of business at 27071 Aliso Creek Drive, Suite 100, Aliso Viejo, California 92656 ("Assignee" and with Assignor, the "Parties").

WHEREAS, Assignor owns the U.S. trademark Miscellaneous Design (), Reg. No. 3,883,943 (the "Mark"), together with the goodwill of the business associated therewith;

WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to transfer to Assignee, all of Assignor's right, title, and interest in and to the Mark, and the parties wish to record this assignment at the U.S. Patent and Trademark Office ("USPTO") against Mark;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Assignor hereby assigns to Assignee, effective as of July 16, 2014, all of Assignor's right, title, and interest in and to: (i) the Mark, together with the goodwill of the business symbolized by the Mark; (ii) the right to bring an action at law or in equity for any infringement, dilution, or violation of the Mark occurring prior to the date of this Assignment, and to collect all damages, settlements, and proceeds arising from such action at law or in equity; and (iii) all administrative rights arising from or relating to the Mark, including, without limitation, the right to maintain the registration and the right to oppose, seek to cancel, or otherwise dispute claims to marks or mark registrations asserted or owned by others.

2. This Trademark Assignment may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
