## SHORT FORM SECURITY AGREEMENT

This Short Form Security Agreement (the “**Agreement**”) is given by **FOTOBAR, LLC**, a Florida limited liability company having a principal executive office at 1040 Holland Drive, Boca Raton, FL 33487 (the “**Company**”), to **PLR IP HOLDINGS, LLC**, a Delaware limited liability company, with offices at 4350 Baker Road, Suite 180, Minnetonka, MN 55343 (“**Secured Party**”) under that certain Secured Loan Agreement dated as of July 16, 2014, between the Company and Secured Party (the “**Secured Loan Agreement**”).

### RECITALS

A. The Secured Party has agreed to lend the Company certain funds (the “**Loan**”) under a Secured Promissory Note dated July 16, 2014 (the “**Note**”).

B. Under the Secured Loan Agreement, the Company has agreed to pledge its intellectual property assets, among other collateral, to the Secured Party as security for its obligations under the Note.

C. This Agreement is provided by the Company for purposes of recording such security interests against the Company’s registrations with the United States Patent and Trademark Office.

### AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Company hereby grants to the Secured Party, a security interest in all of the Company’s right, title and interest in and to all of the collateral listed in the Secured Loan Agreement, including, without limitation, the patent applications, and trademark registrations and applications set forth in Exhibit A attached hereto.

2. This Agreement is provided in connection with the Secured Loan Agreement, which Secured Loan Agreement remains in full force and effect.

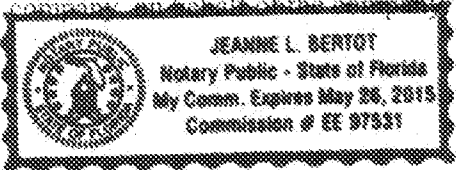

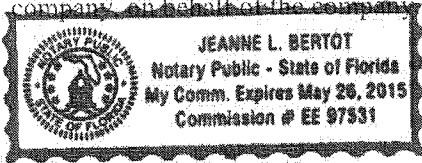

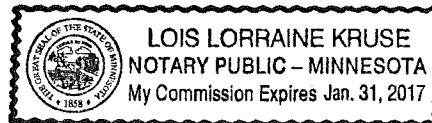
