

This Partial Release of Security Interest in Trademarks is intended to operate as a release of Agent's liens and security interests with respect to the Released Trademarks only and is not intended to release any right, title or interest in any other Patent and Trademark Collateral (as such term is defined in the IP Security Agreement). The IP Security Agreement remains in full force and effect with respect to all of the Patent and Trademark Collateral other than the Released Trademarks.
