

- 2 本转让合同受中国的法律管辖, 并根据中国的法律解释。双方得受中国法院的非专属司法管辖权管辖。





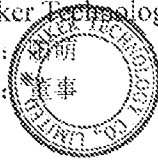


EXHIBIT B

WHEREAS
