9. On or about October 7, 2013, DWHL-1907241 changed its name from "Ragdoll Limited" to "DHX Worldwide Limited," pursuant to the Certificate of Incorporation on Change of Name attached hereto (in photocopy form) as Exhibit "D".

10. 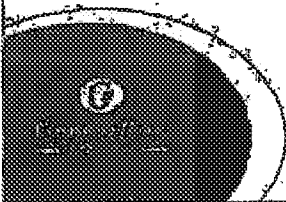

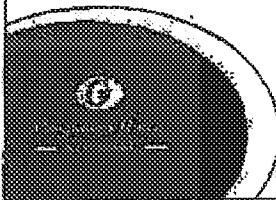

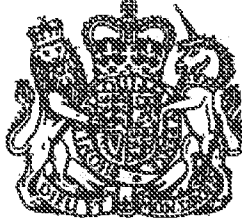
