Assignor hereby assigns to Assignee all of its rights, title and interest in and to the Application, together with the goodwill of the business associated therewith and symbolized thereby in the United States, and together with all rights appurtenant thereto, including, but not limited to, all common law rights, if any, causes of action, all interests, claims and rights for damages, profits and other awards by reason of any past infringement, dilution, misappropriation, or other violation thereof, and the right to sue therefor.




