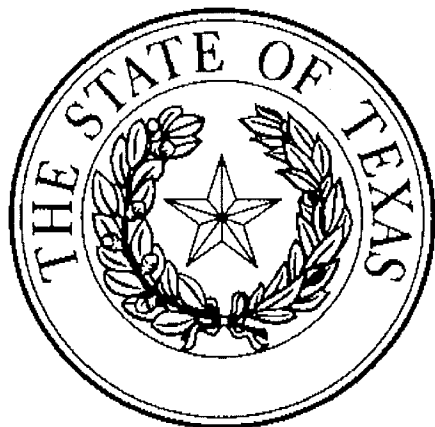

Pursuant to the provisions of Sections 10.010, 10.151 and Title 2 of the Texas Business Organizations Code (the "*TBOC*"), the undersigned nonprofit corporations hereby adopt the following Certificate of Merger for the purpose of effecting a merger of the two entities.

ARTICLE ONE  
MERGING PARTIES INFORMATION

The name, organizational form, state of incorporation and file number issued by the Secretary of State for each organization that is a party to the merger are as follows:

1. **MEMORIAL HERMANN HOSPITAL SYSTEM**, a Texas nonprofit corporation (the "Surviving Corporation"), will survive the merger. The Surviving Corporation was organized in the State of Texas as a nonprofit corporation, and was issued the file number 2259701 by the Texas Secretary of State. The principal place of business of the Surviving Corporation is at 929 Gessner Road, Suite 2700, Houston, Texas 77024.

2. **MEMORIAL HERMANN HEALTHCARE SYSTEM**, a Texas nonprofit corporation (the "Merged Corporation"), will be merged with and into the Surviving Corporation in the merger and the separate company existence of the Merged Corporation will thereupon cease. The Merged Corporation was organized in the State of Texas as a nonprofit corporation, and was issued the file number 60391701 by the Texas Secretary of State. The principal place of business of the Merged Corporation is at 929 Gessner Road, Suite 2700, Houston, Texas 77024.

ARTICLE TWO  
AVAILABILITY OF MERGER AGREEMENT

The signed Merger Agreement is on file at the principal place of business of the Surviving Corporation, which is 929 Gessner Road, Suite 2700, Houston, Texas 77024. Upon written request, a copy of the Merger Agreement will be furnished without cost by the Surviving Corporation to any member of any entity that is a party to the Merger Agreement.

ARTICLE THREE  
AMENDMENTS; NO ENTITIES CREATED

No amendments or changes will be made to the Articles of Incorporation of the Surviving Corporation pursuant to the merger except that they shall be hereby amended to reflect a change of the Surviving Corporation's name to "Memorial Hermann Health System." There are no domestic or foreign nonprofit corporations to be created by the Merger Agreement.

**ARTICLE FOUR**  
**APPROVAL OF THE MERGER AGREEMENT**

The Merger Agreement has been approved as required by the laws of the jurisdiction of formation of each organization that is a party to the merger and by the governing documents of each entity that is a party to the merger.

**ARTICLE FIVE**  
**EFFECTIVENESS OF FILING**




