**ASSIGNMENT OF U.S. AND FOREIGN TRADEMARKS, SERVICE MARKS AND
ACCOMPANYING APPLICATIONS, REGISTRATIONS AND GOODWILL**

WHEREAS, Rieke Metals, Inc., a Nebraska corporation ("Assignor") and Rieke Metals, LLC, a North Carolina limited liability company ("Assignee"), Reuben D. Rieke, Ph.D. and Loretta I. Rieke have entered into that certain Asset Purchase Agreement dated as of June 30, 2014 (hereinafter the "Agreement"), which Agreement, among other things provides for the sale, transfer, conveyance, delivery and assignment to Assignee of the Purchased Assets (such capitalized terms and, except as defined herein, all other capitalized terms used in this Assignment shall have the same meanings ascribed to them in the Agreement);

WHEREAS, Assignor is the owner of and has all right, title and interest in and to the trademarks and service marks described in Exhibit A attached hereto and incorporated herein by reference (hereinafter "Marks");

WHEREAS, Assignor wishes to assign all of its right, title and interest in and to the Marks, together with the goodwill of the business appurtenant to and symbolized thereby, to Assignee.

WHEREAS, Assignee desires to acquire all Assignor's right, title and interest in and to the Marks, together with the goodwill of the business appurtenant to and symbolized thereby;

NOW, THEREFORE, for and in consideration of the sum of \$10.00, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by Assignee, the Assignor and Assignee agree as follows:

1. **ASSIGNMENT.** Assignor hereby assigns, sells, conveys, and transfers to Assignee all of its right, title and interest in and to the Marks, including, but not limited to: (i) all application and registration rights with respect to the Marks, (ii) any renewals or extensions of such applications and registrations, (iii) any goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks, (iv) all income, royalties or claims relating to the Marks due or payable on or after the date of this Assignment and (v) all claims for damages and all remedies arising out of any violations of the Marks that may have accrued prior to the date of assignment or that may accrue hereafter, including, but not limited to, the right to bring suit for, collect and retain damages for past infringement of any of the Marks.

2. **CONTINUING OBLIGATIONS.** Assignor agrees to assist Assignee, upon request and without additional consideration, by taking any reasonable action that may be necessary for the perfecting, securing and completing of the Assignment.

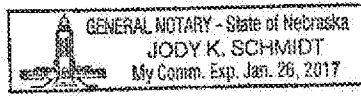

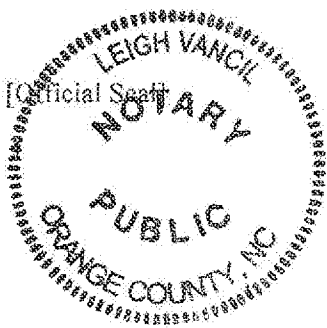
