RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of July 22, 2014 (“Effective Date”) by U.S. BANK NATIONAL ASSOCIATION (successor in interest to RBS CITIZENS, N.A.) in its capacity as administrative agent under the Trademark Security Agreement described below (“Agent”) in favor of PRAIRIE GROVE FARMS OF IOWA, LLC, an Iowa limited liability company (“Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement (as defined below).

WHEREAS, Grantor and Agent entered into that certain Trademark Security Agreement by and between Grantor, Agent and the Lender parties thereto dated November 25, 2008 (the “Trademark Security Agreement”), wherein Grantor granted to Agent a security interest in the Trademarks (as defined in the Trademark Security Agreement), including the trademarks and trademark applications set forth on Schedule A hereto (collectively, the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 3, 2008, at Reel 3897, Frame 0480; and

WHEREAS, Grantor requests a specific release of the security interest granted and recorded against the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) terminates the Trademark Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts necessary to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of Agent’s rights under the Trademark Security Agreement with respect to the Trademark Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of Illinois and applicable federal law.
