DECLARATION OF CHRISTOPHER DODS,
AS CHIEF EXECUTIVE OFFICER OF CLEAN EARTH, INC.

Christopher Dods, as Chief Executive Officer of Clean Earth, Inc., declares:

1. I am the Chief Executive Officer of Registrant, Clean Earth, Inc., a Delaware Corporation (“Clean Earth”), and am authorized to make this Declaration on behalf of the corporation.
2. Clean Earth is the successor in interest to the prior registrant, U.S. Plastic Lumber IP Corporation, a Delaware Corporation (“U.S. Plastic”), and is now the owner of the entire right, title and interest in and to said trademark registration, together with the goodwill of the business symbolized by and associated with the mark by virtue of an Assignment executed on September 9, 2002 and recorded in the United States Patent and Trademark Office, Trademark Assignment Branch on August 9, 2005, Reel/Frame 3137/0529.
3. On September 7, 2006, (i) a Quitclaim Bill of Sale dated April 7, 2006 was recorded in the United States Patent and Trademark Office, Trademark Assignment Branch, Reel/Frame 3384/0899, granting rights in and to said trademark registration to AMPAC Capital Solutions, LLC (“AMPAC”), a Nevada limited liability company,

by U.S. Plastic and (ii) a Quitclaim Bill of Sale dated April 7, 2006 was recorded in the United States Patent and Trademark Office, Trademark Assignment Branch, Reel/Frame 3384/0934, granting rights in and to said trademark registration to Trimax Building Products, Inc., a Nevada corporation, by AMPAC.

4. Given that U.S. Plastic assigned all right, title and interest in and to said trademark registration, together with the goodwill of the business symbolized by and associated with the mark to Clean Earth on September 9, 2002, the assignments recorded at Reel/Frame 3384/0899 and Reel/Frame 3384/0934 are erroneous, as U.S. Plastic had no right, title or interest in or to said trademark as of December 19, 2002.
5. All statements made herein of my own knowledge are true and all statements made on information and beliefs are believed to be true; and further, these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application or document or any registration resulting therefrom.
