RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of July 23, 2014 ("Effective Date") by **SILICON VALLEY BANK**, a California corporation ("Bank"), in favor of **SOCIAL SOLUTIONS US, LLC.**, a Maryland limited liability company, with its principal office at 425 Williams Ct, Suite 100, Baltimore, MD 21220 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Bank dated December 14, 2009 (the "Intellectual Property Security Agreement"), Grantor granted to Bank a continuing security interest in and to all of Grantor's right, title and interest in and to certain Copyrights, Trademarks, Patents and Mask Works owned by Grantor (collectively, the "Intellectual Property Collateral"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantor and Bank entered into the Intellectual Property Security Agreement pursuant to the terms and conditions of that certain Loan and Security Agreement by and between Grantor and Bank dated December 14, 2009 (the "Loan Agreement");

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on September 27, 2010, at Reel/Frame: 4285/0285; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Bank.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby terminates the Intellectual Property Security Agreement and the Loan Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property Collateral.

Bank shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.
