## TERMINATION AND RELEASE OF SECURITY INTERESTS

**TERMINATION AND RELEASE OF NEGATIVE PLEDGE AGREEMENT – TRADEMARKS (SECURITY INTERESTS IN CERTAIN TRADEMARKS) (“Release”)**, dated as of July 14, 2014, by Bank of America, N.A., a national association and successor by merger to Fleet National Bank, as agent (the “Agent”).

WHEREAS, pursuant to the terms of the Negative Pledge Agreement – Trademarks (“Trademark Security Agreement”) dated as of March 27, 2000, between the Agent and KVH INDUSTRIES, INC., a Delaware corporation (the “Grantor”) and recorded with the United States Patent and Trademark Office, at Reel/Frame 002106/0508 recorded on June 26, 2000, for the purpose of securing certain obligations of the Grantor to the Agent, the Grantor granted to the Agent a security interest in and lien on the trademarks identified on Schedule A attached hereto (such trademarks referred to herein as the “Named Trademarks”); and

WHEREAS, the Agent wishes to hereby terminate and release its security interest in each of the Named Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and the Grantor hereby agree as follows:

1. **Release.** The Agent hereby terminates and releases its security interest in and first priority lien on all of the Named Trademarks.
2. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.
