**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of July 28, 2014 (this "Release") is made by GOLUB CAPITAL LLC, a Delaware limited liability company, acting in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of December 28, 2012 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among SPARTA SYSTEMS, INC., a New Jersey corporation, (the "Grantor") and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on January 2, 2013 at reel 4933, frame 0389, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in and to its owned or thereafter acquired or arising trademarks set forth on Schedule 1 hereto; all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark intellectual property license; and all products and all proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any trademark of any trademarks exclusively licensed under any intellectual property license, including right to receive any damages, (ii) injury to the goodwill associated with any trademark, or (iii) right to receive license fees, royalties, and other compensation under any trademark intellectual property license(collectively, the "Trademark Collateral");

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Released Collateral.
