Recitals

(A) The Assignor is the proprietor of the Trade Marks and Patents

(B) The Parties wish to confirm that all right, title and interest in and to the Trade Marks and Patents vests in the Assignee.

Operative Clauses

1. In this Agreement the following words shall have the following meanings:

Effective Date: 13th September 2013

Inventions: the inventions claimed in the Patents and all intellectual property rights in and to such inventions.

Patents: the patents and the applications short particulars of which are set out in Schedule 1 including any continuations, continuations in part, extensions, reissues, divisions and including any patents, supplementary protection certificates and similar rights that are based on or derive priority from the foregoing

Trade Marks: the registered and unregistered trade marks short particulars of which are set out in Schedule 2



2. **ASSIGNMENT**

In consideration of the sum of £1 paid by the Assignee to the Assignor, receipt of which the Assignor hereby acknowledges, the Assignor hereby assigns to the Assignee (with effect from the Effective Date) and the Assignee hereby accepts an assignment of all the Assignor's:

- 2.1 legal and equitable rights in and to the Trade Marks, Inventions and Patents;
- 2.2 legal and equitable rights in and to all goodwill attaching to the Trade Marks
- 2.3 legal and equitable rights in and to all rights of action, powers and benefits arising from ownership of the Trade Marks and / or Inventions and / or Patents in particular the right to sue for damages and other legal and equitable remedies (and retain any financial award made in any action) in respect of all causes of action arising prior to on or after the date of this Agreement.
- 2.4 entire right to be absolutely entitled to any patent granted on the patent applications at Schedule 1 for the full term of such patents and their entire to apply for, be granted and hold patents for the Inventions made under the Patent Cooperation Treaty or the national patent legislation in each of any of the states for which the patent applications are designated and the right to priority;

3. **ATTORNEY**

The assignor hereby irrevocably appoints the assignee as its attorney in its name and on its behalf to execute and do any instrument or thing as may be required by the assignee to enable it to enjoy the full benefit of the rights assigned by this assignment and in favour of any third party a certificate signed by any director or the secretary of the assignee that any instrument or act falls within such authority shall be conclusive evidence that such is the case.

4. **FURTHER ASSURANCE**

The Assignor shall do or procure to be done all such further acts and things, and execute or procure the execution of all such other documents, as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of this Agreement, whether in connection with any registration of title or other similar right or otherwise.

5. **GOVERNING LAW AND JURISDICTION**

- 5.1 This agreement shall be governed by and construed in accordance with the laws of England and Wales.



5.2 Each party irrevocably agrees to submit to the non-exclusive jurisdiction of the courts of England and Wales over any claim or matter arising under or in connection with this agreement.




