THIS AGREEMENT is by and between **ARVIN LAL**, an individual residing at 126 Clifton Place Apt P2001 New Jersey City NJ 07304 ("Assignor") and **SHREDZ SUPPLEMENTS, LLC**, a New Jersey limited liability company with an address at 20 Deacon Way, #M11601, Jersey City, NJ 07304 ("Assignee").

WHEREAS, Assignor has adopted, owned and used the trademark SHREDZ and is the owner of the trademark identified as Shredz, Serial Number 85374070, Registration Number 4197050, which trademark was registered with the United States Patent and Trademark Office on August 28, 2012, a copy of the Registration Statement is attached hereto as Exhibit A (the "Trademark"); and

WHEREAS, pursuant to and as set forth by prior agreement(s) between Assignor and Assignee, Assignor assigns the trademark SHREDZ, any common law rights associated therewith, the registration thereof, and the goodwill associated therewith to Assignee;

NOW, the parties agree as follows:

1. **Assignment.** Assignor does hereby irrevocably assign to Assignee *nunc pro tunc* effective as of August 29, 2012, all right, title and interest in and to the trademark SHREDZ throughout the world, the above-identified registration thereof, together with all derivations thereof and including all goodwill associate therewith, whether based on common law or the laws of the various states, and the right (but not the obligation) to assert such registered trademark and other assigned rights to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past and future acts of infringement that have occurred or may occur..

2. **Expenses.** Assignor agrees without charge to Assignee but at Assignee's expense to execute and deliver to Assignee such instruments necessary or desirable to perfect the above-described transfer of, or to procure, the Trademarks or to maintain the Trademarks before both the United States Patent and Trademark Office and the Trademark Offices of any and all foreign countries, and to cooperate reasonably with Assignee in obtaining and/or providing information that is required in any proceedings relating to the Trademarks.

3. **Rights to Registration(s).** Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and the appropriate official in any other country, to issue any and all additional trademark and service mark registrations or amended registrations that have been or may be granted upon any application or petition for same for the Trademarks or any additional, continuing or divisional applications thereof to, to Assignee, its successors and/or assigns.

4. **Representations and Warranties.** Assignor represents and warrants to Assignee:

(A) Assignor has the right, power and authority to enter into this Agreement;

(B) This Agreement is valid, binding and enforceable in accordance with its terms in all jurisdictions pertaining hereto; and

(C) Assignor is not subject to any agreement, judgment or order inconsistent with the terms of this Agreement.

5. **Entire Agreement.** This Agreement, contains the entire understanding and agreement between the parties hereto with respect to its subject matter and supersedes any prior or contemporaneous written or oral agreements, representations or warranties between them respecting the subject matter hereof.

6. **Severability.** If any term, provision, covenant or condition of this Agreement, or the application thereof to any person, place or circumstance, shall be held by a court of competent jurisdiction to be invalid, unenforceable or void, the remainder of this Agreement and such term, provision, covenant or condition as applied to other persons, places and circumstances shall remain in full force and effect, except as mandated by the ruling.

7. **Agreement to Perform Necessary Acts.** Assignor agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the intention of this Agreement.

8. **Governing Law.** This Agreement shall be construed in accordance with, all actions arising hereunder shall be governed by, the laws of New Jersey.

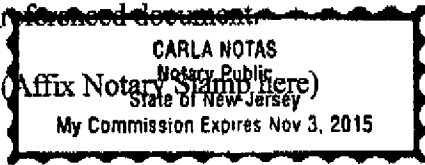


