**TERMINATION AND RELEASE OF SECURITY INTEREST IN
UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of July 8, 2014, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "*Administrative Agent*") pursuant to a Trademark Security Agreement (the "*Security Agreement*") dated as of November 4, 2011 among INSTALLED BUILDING PRODUCTS, LLC, a Delaware limited liability company ("*IBP, LLC*"), RAJAN, LLC, an Ohio limited liability company (together with IBP, LLC, collectively, the "*Grantors*" and each individually, a "*Grantor*"), and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by the Grantors to the Administrative Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 4, 2011 at Reel 004655, Frame 0564;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean all of such Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications set forth on Schedule I hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral without representation, warranty or recourse of any kind or nature.
