Pursuant to Title 8, Section 264 of the General Corporation Law of the State of Delaware ("GCL") and Section 14-11-901 of the Georgia Limited Liability Company Act ("GLLCA"), Springbot, LLC, a Georgia limited liability company, and Springbot, Inc., a Delaware corporation, have duly approved, adopted, certified, executed and acknowledged an Agreement and Plan of Merger in accordance with applicable laws.

FIRST: The corporations that are merging are Springbot, LLC, a Georgia limited liability company ("Springbot GA"), and Springbot, Inc., a Delaware corporation ("Springbot DE"). The surviving corporation of the merger is Springbot DE.

SECOND: The Agreement and Plan of Merger dated as of July 18, 2013 (the "Merger Agreement"), by and among Springbot DE, a Delaware corporation, and Springbot, LLC, a Georgia limited liability company, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Section 264 of the GCL and Section 14-11-903 of the GLLCA.

THIRD: The surviving corporation of the merger is Springbot, Inc.

FOURTH: The Certificate of Incorporation of Springbot DE shall be the Certificate of Incorporation of the surviving corporation.

FIFTH: The merger shall be effective on July 19, 2013 at 12:01 a.m.

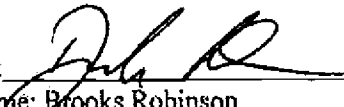
