RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS

This Release of Security Interest in Trademark Rights is granted on this 1<sup>st</sup> day of August, 2014, by HAYFIN SERVICES LLP, an English limited liability partnership, in its capacity as administrative agent for certain lenders (in such capacity, the “Secured Party”), as follows:

W I T N E S S E T H

WHEREAS, SMALL BONE INNOVATIONS, INC., a Delaware corporation (the “Grantor”), previously granted to NEW HEALTH CAPITAL PARTNERS MANAGEMENT LP, a Delaware limited partnership (the “Assignor”), a security interest (the “Initial Security Interest”) in (i) certain trademarks (collectively, the “Trademarks”), more particularly set forth on Schedule A attached hereto, and (ii) the goodwill of the business symbolized by such Trademarks (together with the Trademarks, collectively, the “Trademark Collateral”);

WHEREAS, the Grantor, previously granted to the Secured Party, a security interest (the “Subsequent Security Interest,” and, together with the Initial Security Interest, collectively, the “Security Interest”) in the Trademark and the other Trademark Collateral; and

WHEREAS, the Secured Party wishes to release and terminate the Security Interest of the Secured Party in the Trademarks and the other Trademark Collateral, including but not limited to all filings with the USPTO, if any, that the Secured Party assumed from the Previous Secured Party evidencing the Initial Security Interest in any of the Trademarks and the other Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby releases, discharges, quit claims and relinquishes, in each case, without recourse to, or representation, warranty or other assurance of any kind by, the Secured Party, the Security Interest of the Secured Party in the Trademarks and the other Trademark Collateral.
