TRADEMARK COLLATERAL AGREEMENT (FIRST LIEN)

This 1st day of August, 2014, PENFORD PRODUCTS CO., a Delaware corporation, PENFORD CORPORATION, a Washington corporation and CAROLINA STARCHES, LLC, a South Carolina limited liability company (collectively, “*Debtors*”), in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, assigns, mortgages and pledges to COÖPERATIEVE CENTRALE RAIFFEISEN-BOERENLEENBANK B.A., “RABOBANK NEDERLAND”, NEW YORK BRANCH, as administrative agent for the Secured Parties, and its successors and assigns (“*Secured Party*”), and grants to Secured Party a continuing security interest in, the following property:

(i) Each trademark, trademark registration and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and

(iii) All proceeds of the foregoing, including without limitation any claim by any Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark license, in each case together with the right to sue for and collect said damages;

to secure performance of all Secured Obligations as set out in that certain First Lien Security Agreement dated as of the date hereof by and among Debtors, Secured Party and the other parties thereto (as may be amended, modified or restated from time to time, hereinafter referred to as the “*Security Agreement*”). All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

Notwithstanding anything herein to the contrary, this Trademark Collateral Agreement shall not operate as a sale, transfer, conveyance or other assignment to Secured Party of any applications by any Debtor for a trademark based on an intent to use the same if and so long as such application is pending without a Statement of Use having been filed and accepted (such pending applications which are based on intent to use being hereinafter referred to collectively as “*Intent-To-Use Applications*”), but rather, if and so long as such Debtor’s Intent-To-Use Application is pending without a Statement of Use having been filed and accepted, then this Trademark Collateral Agreement shall operate only to create a security interest for collateral purposes in favor of Secured Party on such Intent-To-Use Application as collateral security for the Secured Obligations. When a Statement of Use is filed and accepted by the Trademark Office, then that application shall cease to be partly exempted from this Trademark Collateral Agreement.

Each Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the assignment, mortgage, pledge and security interest in the trademarks, trademark registrations, trademark applications and trademark licenses made and granted hereby are more fully set forth in the Security Agreement.

If any Debtor shall obtain rights to any new trademarks ownership of any new U.S. applications for registration of and registered trademarks (other than any Intent-To-Use-Applications) included in the Collateral, the provisions of this Trademark Collateral Agreement shall automatically apply thereto. Debtors shall give notice in writing to Secured Party within such time limit set forth in the Security Agreement with respect to any such new trademarks for which such Debtor files an application for registration with the U.S. Patent and Trademark Office or the renewal or extension of any trademark registration. Without limiting Debtors' obligations under this paragraph, upon an Event of Default, Debtors hereby authorize Secured Party unilaterally to modify this Trademark Collateral Agreement by amending Schedule A-1 or Schedule A-2 to include any such new trademark rights registered or applied for trademarks of Debtors. Secured Party shall use commercially reasonable efforts to provide notice to the Debtors of any such amendments to Schedule A-1 or Schedule A-2. Notwithstanding the foregoing, no failure to so modify this Trademark Collateral Agreement or amend Schedule A-1 or Schedule A-2 shall in any way affect, invalidate, or detract from Secured Party's continuing security interest in all Collateral, whether or not listed on Schedule A-1 or Schedule A-2.


This Trademark Collateral Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all such separate counterparts shall together constitute but one and the same agreement. In proving this Trademark Collateral Agreement in any judicial proceedings, it shall not be necessary to produce or account for more than one such counterpart signed by the party against whom such enforcement is sought. Any signatures delivered by a party by facsimile transmission or other electronic transmission shall be deemed an original signature hereto.

This Trademark Collateral Agreement shall be construed in accordance with and governed by the laws of the State of New York.




