**SECURITY INTEREST IN INTELLECTUAL PROPERTY SECURITY SUPPLEMENT**

**TO: BANK OF MONTREAL (the "Bank")**

WHEREAS the undersigned (the "Debtor") has delivered a debenture to the Bank dated as of May 30, 2014 (the "Debenture"), and all terms used herein as defined terms shall have the respective meanings ascribed thereto in the Debenture;

AND WHEREAS pursuant to the Debenture the Debtor pledges, assigns, mortgages, charges and hypothecates to the Bank and grants to the Bank a security interest in favour of the Bank in, *inter alia*, all present and future trademarks, copyrights, patents, trade names, business names, trade styles, logos and all other forms of business identifiers and other intellectual property including, without limitation, the intellectual property set out in Appendix "C" thereto;

NOW THEREFORE for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor hereby grants a security interest in and confirms and agrees that the security interest created by the Debenture has attached to the intellectual property listed on Schedule "A" attached hereto (the "**Intellectual Property**"), and that the Intellectual Property and all proceeds thereof are subject to the security interest granted under the Debenture; all as more particularly provided in the Debenture. The Debtor also agrees to execute and deliver to the Bank all such further documents and assurances from time to time as the Bank may reasonably consider necessary or desirable in connection with the foregoing.

The Debtor confirms and agrees that: value has been given by the Bank to the Debtor; the Debtor has rights in all existing Intellectual Property and power to transfer rights in the Intellectual Property to the Bank; and The Debtor and the Bank have not postponed the time for attachment of the security interest, and the security interest shall attach to Intellectual Property upon the execution of this Agreement. This Agreement is in addition to and not in substitution for any other security now or hereafter held by the Bank (including without limitation the Debenture).

This Agreement shall be governed by the laws of the Province of Ontario and the federal laws of Canada applicable therein.


This Agreement shall be binding on the Debtor and its successors and assigns, and shall enure to the benefit of the Bank and its successors and assigns. The Debtor shall not be permitted to assign its obligations hereunder.


