WITNESSETH:

WHEREAS, Assignor is the record owner of the trademark PANTAURO, and U.S. Appln. No. 86/127,432 for registration thereof on the Principal Register of the U.S. Patent and Trademark Office, filed November 22, 2013 ("Trademark"); and

WHEREAS, Assignor desires to assign and convey to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's right, title and interest in the Trademark; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby assigns, transfers and conveys to Assignee all right, title and interest in and to the Trademark, including the application and registration therefor, together with the entire portion of the goodwill of the business connected with the use of and symbolized by the Trademark, which business is ongoing and existing, and all rights of action accrued, accruing and to accrue under and by virtue hereof including the right to sue or otherwise recover for past infringement of the Trademark and receive all damages, payments, costs and fees associated therewith.

Assignor agrees that, when and as requested by Assignee, Assignor will sign all papers, take all rightful oaths, and do all acts that may be reasonably necessary, desirable or convenient for securing and maintaining the Trademark in all countries and for vesting title thereto in Assignee or Assignee's successors or assigns.

Assignor covenants to Assignee and Assignee's successors, assigns and legal representatives, that the interests and properties hereby conveyed are free from all prior assignments, grants, mortgages, licenses, liens, security interests or other encumbrances.

The Assistant Commissioner for Trademarks is requested to issue the registration issuing from said pending application in the name of the Assignee RED BULL GMBH.
