THIS RELEASE dated as of August 1, 2014 (this "Release") is made by FSJC III, LLC, acting in its capacity as collateral agent (in such capacity, the "Collateral Agent") under (i) that certain Trademark Security Agreement, dated as of December 16, 2010 (as amended, supplemented or modified and in effect from time to time, the "Original Agreement") by and among Emerald Performance Materials, LLC, a Delaware limited liability company, Emerald Polymer Additives, LLC, a Delaware limited liability company, Emerald Hilton Davis, LLC, a Delaware limited liability company, Emerald Kalama Chemical, LLC, a Delaware limited liability company, Emerald Foam Control, LLC, a Delaware limited liability company, Emerald Carolina Chemical, LLC, a Delaware limited liability company, Emerald Specialty Polymers, LLC, a Delaware limited liability company, EPM Emerald (Canada), Inc., a Delaware corporation, CVC Specialty Chemicals Inc., a New Jersey corporation, EPM Polymer Additives Holding Corp., a Delaware corporation, EPM Hilton Davis Holding Corp., a Delaware corporation, EPM Kalama Chemical Holding Corp., a Delaware corporation, EPM Foam Control Holding Corp., a Delaware corporation, EPM Carolina Chemical Holding Corp., a Delaware corporation, EPM Specialty Polymers Holding Corp., a Delaware corporation, EPM CVC Group Holdings, Inc., a Delaware corporation and Emerald Latin America Holdings, a Delaware limited liability company (each an "Original Grantor" and collectively, the "Original Grantors"), Emerald Kalama Holdings, LLC, a Delaware limited liability company ("Kalama Holdings") and the Collateral Agent and (ii) that certain Amendment No. 1 to Trademark Security Agreement, dated as of May 18, 2012 (as amended, supplemented or modified and in effect from time to time, the "Security Amendment", collectively with the Original Agreement, the "Security Agreements") by and among the Original Grantors, Emerald Performance Holding Group, a Delaware limited liability company ("Performance Holding", and together with the Original Grantors and Kalama Holdings, each a "Grantor" and collectively, the "Grantors") and Collateral Agent.

WHEREAS, pursuant to (i) the Security Agreement which was recorded in the records of the United States Patent and Trademark Office on July 8, 2011 at reel 4577, frame 0908 and (ii) the Security Amendment which was recorded in the records of the United States Patent and Trademark Office on July 19, 2012 at reel 4825, frame 0701, the Grantors granted to the Collateral Agent a continuing security interest in all of Grantors' right, title and interest throughout the world, whether then owned or thereafter acquired in trademarks, including those set forth on the attached schedule (the "Trademark Collateral");


