RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "*Release*") is made effective as of July 30, 2014 by General Electric Capital Corporation ("*Secured Party Agent*") in favor of Saddle Ranch Chop House, LLC, a Delaware limited liability company ("*Grantor*").

RECITALS

A. Grantor executed a Security Agreement, dated July 6, 2009 (the "*Security Agreement*"), pursuant to which the Grantor granted a security interest to the Secured Party Agent in certain intellectual property more particularly described therein.

B. The Security Agreement was recorded with the Assignment Branch of the United States Patent and Trademark Office on July 10, 2009, at Reel/Frame 004022/0770, with respect to the trademarks identified on Exhibit A attached hereto (the "*Trademarks*").

C. The security interest granted by the Security Agreement terminated contemporaneously with the payment and satisfaction in full of all Credit Facilities and other Obligations, as such terms are defined in the Security Agreement by and among Borrower, the Lender parties thereto, and Secured Party Agent, dated July 8, 2009.

D. Secured Party Agent has agreed to release all of its rights under the Security Agreement, including the rights in and to the Trademarks covered by the Security Agreement, together with the goodwill associated therewith (the "*Released Collateral*"), and to reconvey any and all rights it may have in the Released Collateral to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Release. Secured Party Agent releases, without recourse or warranty, and reconveys to Grantor, all of Secured Party Agent's right, title, claim and interest in and to the Released Collateral, all proceeds thereof, all rights corresponding thereto and all registrations, reissues, renewals and extensions therefor.
2. Acknowledgment. Grantor hereby acknowledges and accepts the foregoing release and reconveyance by Secured Party Agent.
3. Counterparts. This Release may be executed in two counterparts, each of which shall be deemed to be an original, and all such counterparts shall constitute but one and the same instrument.

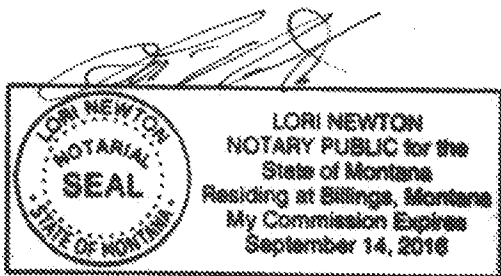
