RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

August 6, 2014

WHEREAS, STERIGENICS U.S., LLC, a Delaware limited liability company (the “**Grantor**”) granted a security interest (the “**Security Interest**”) in and a lien upon certain trademarks and related rights to JPMORGAN CHASE BANK, N.A., as administrative agent (“**Secured Party**”), as set forth in that certain Grant of Security Interest in Trademark Rights dated as of March 25, 2011, including any supplements prior to the date hereof (the “**Trademark Security Agreement**”), by the Grantor in favor of Secured Party, which was recorded in the United States Patent and Trademark Office on March 25, 2011 at Reel 004506, Frame 0078;

WHEREAS, the indebtedness secured by the Security Interest has been paid in full, and the Grantor has requested that Secured Party release and reassign to the Grantor its interest in (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or group of countries or any political subdivision of any of the foregoing, or otherwise, and all common-law rights related thereto, (ii) the right to obtain all renewals thereof and (iii) any agreement (whether or not in writing) providing for the grant by or to the Grantor of any right to use any of the foregoing (collectively, “**Trademarks**”), including without limitation those items identified in Schedule I annexed hereto and made a part hereof; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:


1. terminates, cancels, releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the Trademarks identified in Schedule I and/or any goodwill associated with any of the Trademarks identified in Schedule I, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by the Grantor to Secured Party with respect to the Trademarks identified in Schedule I pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
